As per Government Order No. MWD/03/MDC / 014, Bangalore dated 17.01.2014, the Karnataka Minorities Development Corporation Ltd., (KMDC) has entered into a Memorandum of Understanding (MOU) with Karnataka Examination Authority, Bangalore. Accordingly, applications as per the prescribed format issued under KEA Brochure, are invited from the candidates belonging to religious minorities viz., Muslim, Christian, Jain, Buddhist, Sikh and Parsi communities who are appearing for Common Entrance Test (CET) which will be conducted by Karnataka Examination Authority (KEA) for various Professional Courses, for sanction of education loan from the Corporation under its 'Arivu' (Education Loan) Scheme as per the fee prescribed by the KEA/Government of Karnataka.

The Guidelines are as Under

- The candidate should be a resident of Karnataka either by birth or domiciled in Karnataka for the last 10 Years.
- The annual income of the parents of the candidates should be less than Rs.4.50 Lakhs per annum.
- The Education Loan will be pre-sanctioned to the candidates who are appearing for Common Entrance Test (CET) and subsequently, attending Counselling for selection of seat for professional course in the academic year 2014-15.
- The loan will be pre-sanctioned to the candidates as per CET Gradation.
- The loan will not be sanctioned to the candidates who do not qualify as per CET norms.
- The candidate should submit an 'Undertaking' that in case of surrender of seat or cancellation thereby causing a vacancy after availing loan from KMDC, he/she shall remit the entire amount forfeited by KEA to KMDC.
- The loan amount along with the Service Charges of 2% shall be repaid to KMDC as per the norms of 'Arivu' (Education Loan) Scheme.
- Last Date for submitting applications would be 31.05.2014.

Important Instructions to the Candidates

- The candidates should collect the Application Form either from CET Brochure or down load the

Application Form from Website No. www.kmdc.kar.nic.in and fill-up all the columns as mentioned in the Application Forms.

- The candidates and his/her parents are advised to put signature invariably in the Application Form.
- After filling the Application Form, the Candidate can keep one Xerox copy of Application for his/her reference.
- The original Application Form under 'Arivu' (Education Loan) Scheme along with Xerox copy of Income & Caste Certificate (for 2A/2B/3B and Category-I) and Xerox copy of CET Admission Ticket, must be submitted to the concerned District Office of KMDC and obtain 'Acknowledgement', without fail. The addresses of the District Offices are available in the Website of KMDC.
- The candidate can select any Seat through KEA. The candidate should submit the Application Form along with Xerox Copy of Income & Caste Certificate and Xerox Copy of CET Admission Ticket to all such District Office of KMDC and obtain Acknowledgement. The candidate need not submit the Demand Draft/any Fee to KEA. The KEA will issue Admission Order.
